

The Tianjin Meijiang Convention and Exhibition Center is located in the south of Tianjin city.







Tianjin Geological Tour

Visit Tianjin Jixian National Geopark of China

Ji County has a long and profound history and culture, rich in geological heritage resources and a beautiful ecological environment. In 1984, the State Council approved the establishment of the Jixian Middle-Upper Proterozoic Geology Natural Reserve Area. The Middle-Upper Proterozoic typical section formed during the period from 1800 to 800 million years ago and is famous for its complete stratigraphic sequence, continuous and well-preserved outcrop, clear basal and top boundaries, slight metamorphic rocks, and simple structure. In 2003, the Tianjin Jixian National Geopark of China was approved setup by the Ministry of Land and Resources of P.R.C., thus leading to the establishment of the Jixian Geological Museum in 2008. It has shown natural and is now a charm precious natural and cultural heritage site in China.



Floor Plan - Exhibition Hall




